Terms and Conditions

Option 1 – Armenia & Lebanon 14-day Grand Tour (August 6–19, 2020)

Price: 6985 USD per person in a double room (deposit is only 800 USD during booking!). If you are a solo traveler, you can share a room with another tour participant. However, if you would like to stay in a single room, then the single room supplement is **1270 USD**.

Payment Schedule:

- 800 USD deposit – during booking
- Remaining balance – 60 days before the tour

Price Includes: Dr. Robert Schoch as your tour host throughout the trip, assisted by his wife and research partner Catherine Ulissey; accommodations (13-nights); 3 meals a day – breakfast, lunch, and dinner (except for the first day, which includes dinner only; and the last day, which includes breakfast only); all sightseeing tours and entrances included in the itinerary; English-speaking guide; English-speaking tour leader; transfers in air-conditioned buses; reception at the international airport in Armenia; airport arrival and departure transfers; international flight from Armenia (Yeravan) to Lebanon (Beirut); bottled water during the sightseeing; government taxes.

Not Included: International flights from your country of residence to Armenia (Yerevan) and the return flight from Lebanon (Beirut) to your country of residence; Lebanese Visa; soft and alcoholic drinks; souvenirs and personal expenses.

Option 2 – Armenia only – 10-day Tour (August 6–15, 2020)

Price: 3985 USD per person in a double room (deposit is only 400 USD during booking!). If you are a solo traveler, you can share a room with another tour participant. However, if you would like to stay in a single room, then the single room supplement is **780 USD**.

- 400 USD deposit – during booking
- Remaining balance – 60 days before the tour

Price Includes: Dr. Robert Schoch as your tour host throughout the trip, assisted by his wife and research partner Catherine Ulissey; accommodations (9-nights); 3 meals a day – breakfast, lunch, and dinner (except for the first day, which includes dinner only; and the last day, which includes breakfast only); all sightseeing tours and entrances included in the itinerary; English-speaking guide; English-speaking tour leader; transfers in air-conditioned buses; reception at the international airport in Yerevan; airport arrival and departure transfers; bottled water during the sightseeing; government taxes; health insurance.

Not Included: International flights to and from Yerevan in Armenia; soft and alcoholic drinks; souvenirs and personal expenses.

Option 3 – Lebanon only – 5-day Tour (August 15–19, 2020)

Price: 3985 USD per person in a double room (deposit is only 400 USD during booking!). If you are a solo traveler, you can share a room with another tour participant. However, if you would like to stay in a single room, then the single room supplement is **490 USD**.

Payment Schedule:

- 400 USD deposit – during booking
- Remaining balance – 60 days before the tour

Price Includes: Dr. Robert Schoch as your tour-host throughout the trip, assisted by his wife and research partner Catherine Ulissey; accommodations (4-nights); 3 meals a day – breakfast, lunch, and dinner (except for the first day, which includes dinner only; and the last day, which includes breakfast only); all sightseeing tours and entrances included in the itinerary; English-speaking guide; English-speaking tour leader; transfers in air-conditioned buses; reception at the international airport in Beirut; airport arrival and departure transfers; bottled water during the sightseeing; government taxes; health insurance.

Not Included: International flights to and from Beirut in Lebanon; Lebanese Visa; soft and alcoholic drinks; souvenirs and personal expenses.

Registration Form is a written agreement which is concluded between Travel Company *Grzegorz Poplawski* (hereinafter referred to as the 'Tour Organizer') and a tour guest (hereinafter referred to as the 'Traveler'). The agreement affects a tour organized by the Tour Organizer for the Traveler. The Traveler confirms that all the personal information provided on this Registration Form is correct.

Reservation and Payment: The deposit is required at the time of booking. Upon receipt of the deposit, the Tour Organizer gives the Traveler the right to change the tour date once without additional costs providing that the changes are confirmed up to 365 days before the first day of the initial tour date. The final payment is due 60 days prior to the beginning of the tour. Tour Organizer shall prepare a tour update before the final payment with accommodation upgrade options and additional services if available for Traveler's tour. It is the responsibility of the Traveler to determine that final payment reaches the Tour Organizer on time. Payments are to be made by credit card or wire transfer. The credit card payments incur an additional and non-refundable fee of 3.9% that will be added to the Traveler's payment total amount. For the wire transfer option, any fees charged are the responsibility of the Traveler.

Cancellations and Refunds: The deposit and full payment for the tour is fully refunded if the Tour Organizer cancels the trip for any reason. If the Traveler cancels the reservation or any component thereof, the Traveler is required to submit the cancellation in writing by e-mail. If the Traveler cancels the tour, the deposit is non-refundable. Tour cancellation requests received within 60 days prior to the initial tour date are subject to the following charges:

More than 61 days – loss of the deposit payment

60 – 45 days prior to the initial tour date: 50% of the total tour price per person;

44 – 30 days prior to the initial tour date: 75% of the total tour price per person;

29 – 0 days prior to the initial tour date or nonappearance: 100% of the total tour price per person.

The costs of any supplements purchased are included into the total price of the tour. In the case of reimbursement of any costs paid to the Traveler, all bank charges or credit cards are covered by the Traveler.

During the tour no refund will be made for transfers, sightseeing tours, unused site entries or any other services (including meals, accommodation, or transportation) voluntarily not taken. The Tour Organizer reserves the right to cancel any tour prior to departure in which case a full refund will be sent to the Traveler. The Tour Organizer is not responsible for any costs incurred by the Traveler (e.g. advance airline tickets and travel insurance). Any complaints and refund inquiries have to be made by the Traveler in writing within 30 days after the end of the tour. Complaints and refund inquiries will be considered by the Tour Organizer within 30 days of the date of the inquiry. The complaints and refund inquiries sent in later than 30 days after the end of the tour will not be considered by the Tour Organizer.

Responsibility: The Tour Organizer is not responsible for any unpredictable situations like natural disasters, government actions, weather. The Tour Organizer assures no responsibility for any personal injury, illness, property damage or other loss, expense, accident, death, delay, inconvenience or irregularity which may be occasioned by reason of any matter beyond our exclusive control including but not limited to a delay or cancellation that causes you to miss all or any portion of the tour. Please note, the Tour Organizer cannot accept responsibility for any services which do not form part of the agreement. This includes, for example, any additional services or facilities which the hotel or any other supplier agrees to provide for the Traveler where the services or facilities are not advertised by the Tour Organizer as forming part of the Traveler's holiday and the Tour Organizer has not agreed to arrange them as part of the agreement. The Tour Organizer reserves the right to make necessary changes in the tour itinerary in order to adapt to possible alterations in flight times or other unforeseen circumstances. The Tour Organizer reserves the right to change the itinerary or trip features at any time and for any reason, with or without notice, and the Tour Organizer shall not be liable for any loss of any kind as a result of any such changes. Tour Organizer reserves the right to substitute hotels or attractions. In the event of a change of accommodation, the Tour Organizer guarantees the same standard. In the case of exclusion of the given attraction, visit or the meeting from the itinerary, the Tour Organizer reserves the right to cancel such a visit and in such event the cancellation will be replaced with another site/attraction. The changes contained in this paragraph do not apply to the possible exclusion of our special guest Dr. Robert Schoch from the trip. Such a change would entitle the Traveler to cancel the trip without incurring any cost.

Health Insurance: The Tour Organizer purchases health insurance for the Traveler in AXA Insurance Company. The Insurance purchased by the Tour Organizer covers the insured amounts as specified below, not including chronic diseases or pre-existing conditions. There is a possibility to extend your health insurance policy – the Traveler should contact the Tour Organizer in order to extend health insurance coverage. For insurance purposes, the Insurer requires the insured to sign the statement below.
